- would ensure computer student ratio of 1:20 at least. Proper software along with facility of Broad Band connectivity with the feature of 'internet always on' from any service provider to be ensured.
- 8. The schools affiliated and running upto Senior Secondary Level will provide suitable facilities including the equipment in laboratories/workshops and games for classes XI and XII as per requirements laid down in rules.
- 9. The school will also abide by the conditions of Recognition/NOC prescribed by the State Government concerned
- The school is required to restrict the number of sections as per the infrastructure facilities available in the school 10 as per rule 10.6 of Affiliation Bye-laws.
